

**PARADE GUIDELINES**

Please initial each applicable line to confirm that you have read, fully understood, and accepted the items listed below: (\*required)

**PARADE COMMITTEE \_\_\_\_\_\***

- Composed of parade organizers and parade marshals. Solely responsible for planning and implementing the parade sequence.
- Responsible for implementing the parade guidelines.
- Reserves the right to refuse participation or remove participants not conforming to the guidelines or who are refusing instructions from the parade officials.
- Sequencing and starting time may change as deemed necessary by the committee.
- The decision of the Parade Committee is **FINAL**.

**PARTICIPANTS \_\_\_\_\_\***

- Must follow the instructions of the parade organizers and parade marshals.
- Must submit a completed PARADE REGISTRATION FORM before **April 30, 2026**.
- Must provide a short description of the delegation such as presentation, theme and attire.
- Must CHECK-IN with the parade marshals upon arrival in designated waiting area.
- Must be creative with their participation by bringing life, color and music to their delegation.
- Must wear costumes or outfits that conform to standards of decency.
- Must have all portable external power-source or generators be fully secured.

**PARADE DETAILS \_\_\_\_\_\***

- Parade is **Sunday, June 7, 2026**
- Parade will be along **Madison Ave. from 38<sup>th</sup> Street to 27<sup>th</sup> Street.**
- **Assembly time** will be from **10:00 AM to 11:30 AM.**
- **Opening ceremony** will be at 11:45 AM. Parade will **START** at exactly **12:00 NN.**
- Participants who arrive **LATE** will march after all other groups have marched.
- Participants are **NOT ALLOWED** to transfer to another delegation unless they wear the prescribed outfit of the respective organization.
- The parade will take place in **RAIN** or **SHINE.**
- The **REVIEWING STAND** on Madison Ave. between 29th & 30th Streets is **STRICTLY** for authorized individuals, special guests and parade judges.

**PARTICIPANTS WITH OPEN-TOP CONVERTIBLE CAR \_\_\_\_\_**

- Must submit **PAYMENT** of \$300 for Community Organization or \$500 for Private/ Business Entity to the Parade Committee.
- Must know that **FEE IS NON-REFUNDABLE** if parade is cancelled due to inclement weather.
- Must have valid vehicle registration, driver's license, and liability insurance ready at all times as required by the State of New York.
- Must have a driver who is at least 18 years old with a valid driver's license.
- Must have a valid New York State Emission and Safety Inspection sticker.

- Must have at least one FIRE EXTINGUISHER rated 2A: 10B: C on all parade motorized decorated vehicles.
- Must maintain a safe distance between the marchers and the moving vehicle (Car).
- Must NOT allow riders to embark or disembark while the vehicle is moving.
- Must NOT allow children below 12 to ride in Open-Top Convertible Cars unless accompanied by adults and properly fastened. Must not allow riders on the roof or hood of vehicles.
- Must have an exhaust system or pipes in proper working condition so that drivers, riders and marchers will not be exposed to CO2.
- Must not allow smoke belching vehicles.
- Must not allow smoking inside the vehicle or within the vicinity of parade vehicles.
- Must have all vehicles remain in the traffic lanes of the roadway.
- Must not allow blowing of horns or sirens unless it is an EMERGENCY situation.
- Must read, understand and sign the RELEASE, INDEMNIFICATION & HOLD HARMLESS AGREEMENT on **PAGE 5** of this Parade Registration Form.

#### **PARTICIPANTS WITH FLOAT**

- Must submit **PAYMENT** of \$3,500 for PIDCI-Supplied Float or \$1,000 for NON-PIDCI-Supplied Float to the Parade Committee.
- **For PIDCI-supplied floats**, participants must **promptly** pay the required deposit of \$1,750 to **reserve** their float, and the remaining balance of \$1,750 no later than **April 1, 2026**
- For non-PIDCI-supplied FLOAT, must pay fee before **April 1, 2026**.
- Must know that the **DEPOSIT IS NON-REFUNDABLE** if parade is cancelled due to inclement weather.
- Must not exceed the maximum weight capacity of riders allowed by law.
- Must be liable for any float damages due to rider's misconduct and excessive weight.
- Must request the FLOATMAKER or DRIVER to attach or remove anything from the float such as banners and decorations. Makers already prepared the float.
- Must know that FLOATMAKERS have complete supervision and authority over the floats and riders.
- Must keep the float **CLEAN AT ALL TIMES** by providing trash bags and not leaving the trash on the float after the parade.
- Must maintain a safe distance between the marchers and the moving vehicle (Float).
- Must not allow riders to embark or disembark while the vehicle (Float) is moving.
- Must not allow children below 12 to ride on floats unless accompanied by adults and properly fastened.
- Must provide transportation for float riders after the parade. Float drivers will not drive back to the line-up site due to insurance regulations.
- Must NOT allow **SMOKING** on or within the vicinity of parade floats. Must NOT allow **ALCOHOLIC BEVERAGES** on or around the float or **YOU** will be removed from the parade **IMMEDIATELY**.
- Must provide its own **GENERATOR** that must be fully secured and moved safely.
- Must read, understand & sign the RELEASE, INDEMNIFICATION & HOLD HARMLESS AGREEMENT on **PAGE 5** of this Parade Registration Form.

**NOT ALLOWABLE \_\_\_\_\_ \***

- **NO** items, objects, products, giveaways, brochures or materials, etc. will be allowed to be distributed or to be thrown from any float, car and marchers.
- **NO** motorcycles, trailers, rollerblades, skateboards, scooters, balancing scooter, electric skateboards & remote-controlled cars/planes/drones will be allowed.
- **NO** enclosed motor vehicles will be allowed for security reasons but only registered Open-Top Convertible Cars.
- **NO** fireworks or flammable objects will be allowed to be carried and **NO SMOKING** during the parade.
- **NO** releasing of balloons and other flying materials will be allowed.
- **NO** disruptive anti-government placards or negative chanting will be allowed. Public disturbance will not be tolerated.

**RELEASE, INDEMNIFICATION AND HOLD HARMLESS AGREEMENT**

I, on behalf of the organization, its members and family members, acknowledge that our participation in the Philippine Independence Day Parade, Street Fair and Cultural Show involve known and anticipated risks which could result in physical and emotional injury, paralysis or permanent disability, death and property damage. We expressly accept and assume all the risks inherent in this activity or that might have been caused by negligence of the RELEASEES. Our participation in this activity is purely voluntary, and we elect to participate despite the risks. In addition, if at any time we believe that event conditions are unsafe or that we are unable to participate due to physical or medical conditions, then we will immediately discontinue our participation.

We hereby voluntarily release, forever discharge and agree indemnify and hold harmless the Philippine Independence Day Council, Inc., its directors, officers, agents, volunteers and participants, from any and all claims, demands or causes of action which are in any way connected with our participation in this activity, or our use of their equipment or facilities, arising from negligence. Should RELEASEES or anyone acting on their behalf be required to incur attorney fees and costs to enforce this agreement, we agree to indemnify and hold them harmless for such fees and costs.

By signing this document, we agree that if we are hurt or our property is damaged during our participation in this activity, then we may be found by a court of law to have waived our right to maintain a lawsuit against the parties being released on the basis of any claim of negligence. We have had sufficient time to read this entire document and, should we choose to do so, consult with legal counsel prior to signing.
